Susan (Berg) Heins, 100, of Aurora, passed away Friday, November 9, 2012. She was born August 10, 1912 in Aurora, IL to William J. and Anna (Kahl) Berg. Susan graduated from Annunciation B.V.M. School and was a 1929 graduate of Madonna High School. She married Leo A. Heins on October 19, 1938, who died on December 1, 1956 at the age of 46.

Susan was a member of Our Lady of Good Counsel Church since 1942 and was the parish secretary for almost 35 years, retiring at the age of 82. During this time she was a dedicated secretary to: Rev. Sylvester J. Eye, Rev. Robert Jackson and Rev. Edward Gillespie. She was also a member of the Sanctuary Sodality and The Ladies of Columbus. Before her marriage, she was employed at Richard-Wilcox for 10 years as secretary of the elevator equipment division.
